

## SWIMMING POOL RULES

1. The pool will be open daily from 1:00 to 6:00 p.m. (except on Monday) during June, July, and August. These hours are subject to change.
2. If the lifeguard is not on duty, the swimming pool is closed and anyone using the pool is doing so at their own risk. No one under the age of 16 may swim when the lifeguard is not on duty.
3. Running and scuffling around the pool is prohibited.
4. Any guest of a club member must be an out-of-parish, in-house guest. Guests that live in the parish can only use the Club facilities during special events, such as the Member Guest Tournament.
5. Do not talk to lifeguards unnecessarily. They are there for your protection and must be alert.
6. Children under 8 years of age must be accompanied by a responsible adult at all times.
7. Swimmers may be asked to prove their swimming ability before using the deep end of the pool.
8. All swimmers must wear proper bathing suits. Cut-off jeans are not permitted.
9. Wet bathing suits are not permitted in the Club House. No one in a bathing suit, wet or dry, is permitted on the golf course.
10. Swimmers must furnish their own towels.
11. Pets are not allowed in the pool area.
12. Due to state health regulations, persons with skin disorders are not allowed to use the pool.
13. Drinks and food should not be consumed in or over the pool. Glass is not allowed in the pool area, only plastic and paper bottles or cups.
14. Only one person on the diving board at a time. Divers must dive from the front of the board. Divers must swim quickly out of the way of the other divers.
15. Swimmers use the pool area at their own risk.
16. Non-member babysitters may sit in the pool area, but are not allowed to swim unless there is an emergency.

## RENTING THE CLUB HOUSE

1. Club members may apply to the Board of Directors for permission to rent the Club House at times which do not interfere with regular member usage.
2. An application must be completed by a member in good standing and returned along with a \$300.00 fee to the Pro Shop Manager or Club Secretary with the agreement that if the facility is left in the same condition as prior to rental a \$50.00 refund will be returned to member making the rental request. Determination of needed cleaning will be made by Pro Shop Manager. The \$300.00 fee is refundable to club member if the function is cancelled.
3. The application must be approved by the Board of Directors. If the application is not approved, the \$300.00 fee will be refunded.
4. The area included in the rental agreement is the entry, hall, meeting room, kitchen, and rest rooms. The bar room and swimming pool are not included.
5. The club member making the rental request agrees to be totally and personally responsible for any and all damages that may occur during the function.
6. The member making the rental request must agree to be present at the function until its conclusion.



### CLUB CLOSES AT 10:00 p.m.

No one is to be anywhere on the Club grounds after 10:00 p.m. unless prior arrangements have been made with Club Manager or Club Secretary. Any unauthorized entry onto Club grounds after the Club is closed will be treated as trespassing and will be prosecuted.



## LaSalle Golf and Country Club

### Rules and Regulations

Revised May 2011

Violations of any of the following rules could result in either a reprimand, censure, fine, loss of privileges, suspension, or expulsion.

### GOLF COURSE REGULATIONS

1. The Club Manager shall enforce golf course rules and will report any violations to the Rules Committee.
2. U.S.G.A. rules of golf, as augmented by the local rules, shall govern all play.
3. All members should practice proper golf etiquette at all times while on the course.
4. All guests must register in the Pro Shop. All applicable guest fees must be paid before playing.
5. Groups continuing play on #10 have priority over groups starting on #1.
6. No other group has priority over a foursome. Smaller groups should adjust to the pace of the field.
7. Allow faster groups to play through if you have a complete hole open in front of you.
8. Each player must have his or her own clubs.
9. Replace divots in the fairways and repair ball marks on the green.
10. All course signs must be observed.
11. Place trash in receptacles provided.
12. Golf bags and pull-carts must be kept at least ten (10) yards from any green.
13. Players must dress in accord with accepted standards of good taste. A shirt with sleeves must be worn at all times. No tank tops. No vulgar printing on shirts.

14. Children under the age of twelve (12) will not be allowed on the golf course unless properly equipped and accompanied by a responsible adult.
15. After playing a shot from the sand trap, rake the sand back to a smooth condition.
16. No children under the age of thirteen (13) may be left at the Club House or on the golf course without the supervision of a responsible adult at all times.
17. Single players should try to join with a group especially on the weekend. Also six or more players in a group should not play on the weekend.
18. Practicing in one spot (hitting more than four balls) on the fairway and tee boxes is not allowed. A practice range is provided for that purpose.

## GOLF ETIQUETTE

1. Let fast groups play through if there is an open hole in front of you. Single players have no right-of-way.
2. Repair ball marks on the greens.
3. Replace divots on the fairways and tee boxes.
4. Move away from the green as soon as the hole is finished.
5. Be ready to hit your shot as soon as it becomes your turn.



## GOLF CART REGULATIONS

1. Minimum cart tire size is 800 x 6.
2. Carts must be operated safely at all times. Persons under the age of thirteen (13) cannot

operate a golf cart unless accompanied by their parent or a responsible adult.

3. When the course is wet, do not drive carts through bare spots, wet or soft areas, or fairway drainage ditches. To cross the ditches in the fairway, use the culvert or bridge crossings. Drive along tree line and walk out to your ball in the fairway.
4. Carts should never be driven near greens or over tee boxes.
5. The Club shall not be responsible for damages caused by any golf cart being operated on Club premises. The cart operator shall be solely responsible for any damage he or she may cause themselves or their equipment, to any other person or equipment, or to any part of the premises.



## NEW MEMBERSHIP

1. Anyone wishing to join the Club must complete an Application for Membership form and submit it along with an initiation fee to the Board of Directors. At the next scheduled Board Meeting (1<sup>st</sup> Tuesday of each month), the Board of Directors will vote on the acceptance of the prospective new member. The Club Secretary will then notify the prospective new member of the Board's decision by mail or by phone. If for some reason the prospective member's application is not approved, the initiation fee will be refunded.
2. According to the instructions on the current Application for Membership, the new member must pay \$365 in full along with completed Member Application Form. Membership includes \$65 for stock certificate.
3. Prospective new members are allowed to play three (2) rounds of golf prior to joining.

## DELINQUENT MEMBERS

1. Members that become ninety days (90) past due will be notified of this delinquency by mail. If no attempt is made to correct this situation within ten (10) days of receipt of notification, the club member will be dropped from membership.
2. Members wishing to be removed from membership in the club should notify the Club Secretary to avoid being billed for future months.
3. Members that are ninety (90) days past due will not be allowed to participate in Club Tournaments.
4. Members that are sixty (60) days past due will not be allowed to charge in the Pro Shop.

## RE-INSTATEMENT OF MEMBERSHIP

Previous members that want to re-join the Club may do so by paying a re-initiation fee of \$300 plus all past due amounts, if any, from earlier membership. Re-instating members may pay the \$300 fee in three equal payment of \$100 plus monthly dues and cart shed fees if applicable plus any past due balance in full.

## CLUB GUESTS

1. Out-of-parish, in-house guests of a club member in good standing may play by registering at the Pro Shop and paying a guest fee for each day played.
2. A former member who is not in good standing or who owes the Club any past due amount of money cannot be a guest in any Club facility and cannot play the golf course as a guest nor a tournament participant until he or she is restored to good standing with the Club and has paid all outstanding debts in full to the Club.
